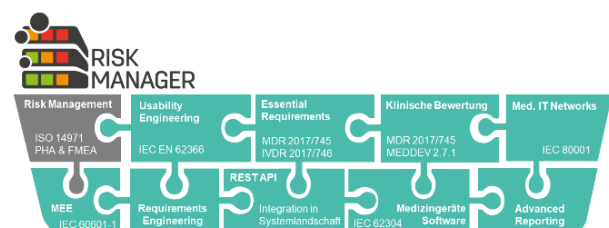
Challenge: Find a perfectly matched system
